### ANSI 2nd Annual Standards Simulation Competition

SES would like to provide you early notification that ANSI, in collaboration with John Deere, will hold its 2nd standards simulation competition on Friday, 27 October 2017 hosted by San Jose State University in Santa Clara, California. This competition will bring together university teams – each made up of five students and one professor – who will represent stakeholders in the development of an international standard. Teams are encouraged to encompass students from across multiple disciplines. Judges from ANSI's standards community will observe each team's strategies, tactics, and interactions, and make recommendations for scores based on how well each team has met its objectives in the development of the standard. Participation is open to university teams only, and space is limited to no more than six teams. Multi-disciplinary teams consisting of undergraduate or graduate students is highly encouraged.
