Assignment of Circuit, Associate Circuit, and Commissioner Cases

The Court hereby makes the following Order with regard to the initial assignment of all case types to all divisions of the Court effective January 9, 2026. This Order supersedes all previous orders regarding the assignment of cases.



Additional case assignment rules:

1. Upon assignment of criminal cases or probation violation cases, to the circuit or associate division, the clerk shall look for pending cases and endeavor to assign all cases for a single defendant to the same judge.
2. All disqualifications granted in circuit court criminal and circuit court civil cases shall be randomly reassigned among all circuit divisions.
3. All disqualifications granted in associate circuit or family court cases shall be randomly reassigned among those divisions eligible for initial assignment of that case type.
4. All disqualifications granted in adult abuse order of protection cases shall be reassigned among all circuit and associate circuit divisions.
5. Traffic cases are included in the associate circuit criminal case type. Those cases currently filed through the PA Portal shall be assigned by the auto creation option for the non-appearance case automate charge system. Cases filed through this system are not subject to pending case review for assignment of judges.
6. Dissolution, Paternity, or Modifications in domestic cases presented by affidavit will be heard by the commissioner assigned the case.
7. The Presiding Judge may make special assignment to any judge or commissioner of certain cases, civil or criminal, based on potential judicial conflicts, judicial economy, and available judicial resources.

The Circuit Clerk is directed to make arrangements to facilitate this Order.
