## **MEMBERS OF BUILDING OFFICIALS ASSOCIATION HELP CONSTRUCT READING AND LEARNING CENTER**

SACRAMENTO, Calif.—More than 10 members of the Sacramento Valley Association of Building Officials (SVABO) have volunteered their time and professional skills to help build a computer-equipped reading and learning center at St. John’s Shelter Program for Women and Children in Sacramento. The center will be a resource for adults to job search and for children to study.

SVABO’s Community Outreach Committee Chair Craig Sarmento is always looking for projects within the community for the committee to be a part of. Greg Gonzales, St. John’s board treasurer, is a friend of Sarmento’s and encouraged the committee to help with the reading and learning center project.

Sarmento said he was interested in this project because the shelter is at its capacity and people are being denied services. St. John’s currently shelters 112 women and children, and daily turns away about 350 women and children.

“The reading and learning center was a good opportunity to help the children onsite improve their education,” Sarmento said.

The committee began working on the center on Saturday, July 25, and has continued work in their spare time on the weekends. Members transformed an old portable school building into a state-of-the-art learning center by installing a handicap ramp, a door, wood and carpet

flooring, and an electrical system. Sarmento anticipates that the committee's work will be finished by the end of September.
