(WS01) Pharmacology Update

Basic wound closure is a must for the NP in the office, operating room or emergency department. This workshop will discuss wound healing, multiple types of wound closure with the opportunity for each participant to practice and receive help from experts in the area of suturing in a non-threatening and friendly manner. Only 10 -20 percent of substance use disorder patients seek specialized treatment for their disorder. Texas has one of the highest maternal mortality rates in the world. Teen births are 58 per 1000, while the national average is 46/1000. By age 20, about 20 percent of white teens and 40 percent of Hispanic and black teens will have been pregnant. Good news is the birth rate for teenagers, age 15-19, declined 10% in 2013 from 2012 (79 percent over five years) to 26.5 births per 1,000 teenagers and cut the abortion rate by 77%, another historic low for the nation. The birth rate for unmarried women declined for the 5th consecutive year in 2013. A large part of this decrease is due to the Long-acting Reversible Contraception (LARC). In this 3-hour workshop you will be trained on the effectiveness, the differences and insertion/removal of IUD LARCs. **(3.25CE; 3RX)**

(WS14) Integrative and Functional Medicine 101: Basic Concepts Across the Lifespan

Emily Gutierrez, DNP, PNP-C, IFM-CB

Come learn about integrative and functional medicine, a systems-based biological approach that shifts the focus from managing the symptoms of disease to exploring the root causes of chronic illness. Applications for conditions such as the common cold/viral illnesses, irritable bowels, hypertension, hyperlipidemia, headaches, fatigue, eczema, pain, ADHD, depression, anxiety, OCD, and autism will be explored. Literature has indicated that overall antibiotic prescribing is greater in the elderly population. It is not uncommon for the elderly to receive overly broad antibiotics or treatment for a prolonged duration. This presentation will focus on the physiologic changes of aging, diagnostic challenges, antibiotic dosing, drug interactions, and resistance. **(1CE; .75RX; 1G)**

(F12) Validation of Practice Based Evidence for Effective Management of Chronic Migraine and Occipital Neuralgia in the Post 9/11 Combat Veteran

(F13) Depression and Altered Mood States in Peri and Post Menopausal Women: Understanding the Role of Sex Hormones

Most NP programs and medical schools in the United States teach students to ask the same three questions when obtaining sexual history from patients. Information obtained in a well-structured sexual history can provide insight into the effectiveness of chronic disease management, health promotion and risk reduction. Knowing what to ask and how to ask the important questions is an essential competency for all Nurse Practitioners and requires periodic updating. **(1CE; .8E)**

(F22) Learning From the Past: Vaccine Challenges

This session examines the social and pathophysiologic underpinnings of vaccine development and adverse events, including historic vaccine tragedies and (pseudo)scientific arguments used by vaccine skeptics. By improved understanding of the reservations of vaccine resistant families, providers will be better prepared to offer reasoned and persuasive counter arguments. The current AAP Refusal to Vaccinate Policy will also be discussed, in juxtaposition with the current Parental Rights movement and vaccine legislation, as well as documentation of vaccine refusal. **(1CE; 1RX)**

(F23) Care Expectations: Bridging the Care of Migraine from the Clinic to the ED

Care coordination between the ED and the ambulatory clinic is challenging for many reasons. One population that would benefit from consistent evidence based expectations across the care continuum is the patient with migraine headache. (GS05): Comprehensive Care in COPD: Strategies for Nurse Practitioners

COPD, a slowly progressive respiratory disease comprising emphysema, chronic bronchitis, and some forms of bronchiectasis, is the third leading cause of death in the United States and is projected to become the third leading cause of death worldwide by 2020. Approximately 15 million adults have a diagnosis of COPD, but the true number of individuals with COPD may be considerably higher. Treatment goals include symptom management and reduction of future risk. However, many patients with COPD are not achieving these goals due to delayed or missed diagnoses and/or suboptimal treatment. This activity will examine risk factors, strategies for the recognition and assessment of early symptoms, criteria for diagnosis, and the implementation of a comprehensive patient-centered approach to disease management. **(1CE; .25RX; 1G)**
