

2025 TNA ANNUAL CONFERENCE - INFORMATION & REGULATIONS FOR SPONSORS AND EXHIBITORS

Conformance with these Regulations is understood to be part of the contract.

- 1. CONTRACT: Completed contracts must be received by the Texas Nurses Association no later than January 15, 2025 to receive early bird pricing or no later than April 30, 2025 for regular pricing.
- 2. PAYMENT: Payment for the contracted rate must be received within 30 business days of notification that your contract has been accepted.
- 3. SPACE ASSIGNMENT. Assignment of space will consider sponsorship level first, and exhibitors will be assigned in the general exhibit area as their contracts are received care will be taken to not place any exhibitor or sponsor near a direct competitor.

No exhibitor shall assign, sublet, or share the whole or any part of his assigned space without approval of the Texas Nurses Association.

4. SPACE ARRANGEMENT. Each exhibit space is 8'X10' with 3' side drapes and an 8' back drape. Each space contains one 6'X30" draped table, two chairs and a trash can. Additional furnishings may be rented from the official exhibition service, Superior Expo. Electricity and internet may be secured from Markey's. Pricing and order information will be shared upon the acceptance of a signed contract.

Exhibits should not be placed in such a manner as to interfere with other exhibitors. No tall sidewall panel shall project further than 30" from the wall and no equipment of abnormal height shall be allowed. There shall be no obstruction in the aisles. Exhibits must present an attractive appearance. Exhibitors desiring a variation from the above must send plans and or photos to TNA for approval.

- 5. CANCELLATION AND REFUND POLICY. A liquidated damage charge of 30 percent of the exhibit fee will be assessed for all cancellations prior to April 30, 2025. No refunds will be issued after April 30, 2025.
- 6. EXHIBIT SET-UP. Thursday, June 5, 2025, Move-in begins at 12 Noon and must be completed by 5:00 p.m.
- 7. SECURITY. No security is being provided in the exhibit hall. Door will be locked when the exhibits are not open.
- 8. EXHIBIT DATES AND HOURS.

Thursday, June 5, 2025: 5:00 p.m. – 7:00 p.m. Friday June 6, 2025: 7:00 a.m. - 4:00 p.m. Saturday, June 7, 2025: 7:00 a.m. – 1:00 p.m.

- 9. DISMANTLING OF EXHIBIT. No packing of equipment, literature, other material or dismantling of exhibits will be permitted before 1:00 p.m. on Saturday June 7 without notification of and approval from the exhibit manager. All exhibit materials must be packed and removed from the exhibit area by 5:00 p.m. on June 7. The exhibitor is responsible for seeing that the exhibit is properly labeled boxes and bills of lading prepared for return shipment. The Texas Nurses Association assumes neither responsibility nor liability for any exhibit items.
- 10. PRESENTATION OF PRODUCTS & SERVICES. All demonstrations, sales, discussion, or other activities, such as the distribution of descriptive literature, must be confined to the exhibitor's own booth. If cash sales and order taking are undertaken, then Texas sales permit must be in evidence and correct sales tax collected. All methods and manners of sales shall be proper, and any exhibitor shall be subject to eviction without a refund if his sales procedure is objectionable.
- 11. EXHIBIT REPRESENTATIVES. Each exhibitor must provide a representative within their exhibit space during designated exhibit hours. All exhibitors must register their representative(s) in advance. Exhibit representatives are limited to two. Additional representatives may participate at a cost of \$175 per person. Any additions or changes in registration made during the event must be certified by the exhibitor's authorized representative (booth manager or agent). Exhibitor badges may be picked up at the Exhibitor Registration Area on the lower level of the Renaissance Arboretum Hotel beginning at Noon on Thursday, June 5, 2025.

False certification of individuals as exhibitors' representatives, misuse of exhibitors' badges, or any other method or device used to assist unauthorized persons to gain admission to the conference will be cause for expelling the violator from the exhibit area without obligation on the part of TNA for refunding of any fees.

- 12. DISTRIBUTION OF SAMPLES AND SOUVENIRS.
 Distribution of samples and souvenirs is permissible in the exhibit area only, provided it is done in a dignified manner, does not create a nuisance and causes no interference with adjoining exhibits.
- 13. PROTECTION OF PROPERTY. Nothing shall be pasted, tacked, nailed, screwed, or otherwise attached to columns, walls, floors or other parts of the building or furniture. Exhibitors violating this regulation are expressly bound, at their expense, to repair any damage to property that they may cause.

- 14. FIRE AND SAFETY. All flammable materials must be flameproof before being placed in the exhibit hall. All materials and installations are subject to fire and safety regulations in force by the state and City of San Antonio. Volatile or flammable fluids, substances or materials of any nature prohibited by the city fire regulations or insurance carriers are prohibited in any booth.
- 15. LIABILITY. Exhibitor assumes entire responsibility and hereby agrees to protect, indemnify, defend and save the Texas Nurses Association and the Renaissance Austin Arboretum and its owners, employees and agents harmless against all claims, losses and damages to persons or property, governmental charges or fines and attorney's fees arising out of or caused by Exhibitor's installation, removal, maintenance, occupancy or use of the exhibition premises or a part thereof, excluding such liability caused by the sole negligence of the Hotel, its owners, employees and agents.

In addition, the exhibitor acknowledges that the Texas Nurses Association and the Renaissance Austin Arboretum do not maintain insurance covering exhibitor's property and that it is the sole responsibility of exhibitor to obtain business interruption and property damage insurance covering such losses by exhibitor.

- 16. HOTEL RESERVATIONS. TNA has made arrangements for special rate of \$229 per night, plus applicable taxes and fees at the conference hotel, Renaissance Austin Arboretum Reservations must be made prior to May 25, 2025 here: https://www.marriott.com/event-reservations/reservation-link.mi?id=1730147972099&key=GRP&guestreslink2=true
- 17. IRREGULAR ACTIVITIES. (1) Noisemakers, side show antics and other undignified promotion methods and materials considered to be objectionable are expressly prohibited. (2) The consummation of a contract of sale or selling of products or exhibits for cash or charge without a Texas sales permit and collection of required sales tax is not permitted. (3) No exhibitor shall assign, sublet, or share the space allotted without the knowledge and consent of the Association. (4) Publicizing or maintaining any extraneous activities, inducements, demonstrations, or exhibits away from the exhibit area during the exhibit hours is not permissible. (5) Exhibitor activities must comply with the regulations of the Renaissance Hotel Austin at the Arboretum, the City Fire Codes, as well as those of the Association. (6) Registrants shall not be solicited in the aisles. (7) All presentations and demonstrations shall be confined to the exhibitors' booth unless special arrangements are made with the TNA exhibit manager. (8) no helium balloons are allowed in the exhibit areas.

- 18. FAILURE TO OBSERVE RULES. Violations of any of these regulations on the part of the exhibitor, his employees, or agents, shall at the option of the Association, forfeit the right to occupy space and such exhibitor will forfeit to the Association all monies paid.
- 19. RULES ARE A PART OF THE CONTRACT. These rules and regulations are to be construed as a part of all space contracts. The management reserves the right to interpret them as well as make final decisions on all points which the rules and regulations do not cover.
- 20. FURNISHINGS, ELECTRICITY, INTERNET, SHIPPING: Contracted vendors will receive a vendor service kit from Superior Expo with information for renting additional furnishings and carpeting for their exhibit space. The kit will also include a link to order electricity and internet from Markey's, the in-house audio-visual company, as well as complete instructions for shipping to/from the hotel.
