A complete application consists of the following:

- Table of Contents
- Application Questions
- Essay
- Curriculum Vitae
- Supplemental Information
- Letters of Recommendation

Please submit your answers to the application questions using the following format:

- Cover Letter to include Name, Hospital, and Contact Information
- 8.5 x 11-inch white paper
- One-inch margins all around
- Arial 12-point font
- Lines left – justified
- Double-spaced lines
- Each page should be numbered with your name in the bottom right-hand corner.
- Each question should be numbered and titled
- Table of Contents

### **Application Questions**

#### **1. TCAA Membership**

- a. How have you utilized your TCAA membership to support your trauma program?

#### **2. Academic, CE Background, and Overall Knowledge Base**

- a. List your academic and continuing education background.
- b. Include all finance, management, and trauma-related education completed.
- c. How long have you been in the Trauma Program Manager role?
- d. Describe your overall knowledge of trauma center operations and finance.

#### **3. Trauma Finance Accomplishments**

- a. Describe your role in trauma center finance.

#### **4. Trauma-related Activities and Interests**

- a. Elaborate on your personal and professional interests, activities and accomplishments, as well as any special circumstances you feel are relevant.
- b. Give examples of how you've changed management – i.e., creative accomplishments, PI projects, leadership challenges

#### **5. Career Path/Professional Goals (for 5yrs. or 10yrs.)**

- a. Describe your ideal career path.
- b. Describe your goals in trauma care.

#### **6. Administrative Support**

- a. Describe your administrative program's level of support for your involvement in this educational endeavor.

#### **7. Project Proposal**

- a. Select your preferred project topic from the chart below and explain your interests and motivation in your chosen topic. *Please note: final project topic approval is based on availability of topic area and current member needs. **Curriculum Vitae**

Please submit a resume that includes your employment history with titles and dates. Your educational record should also be included and should indicate dates of attendance and degree(s) earned. Other information including trauma professional memberships is welcomed and encouraged.

**Supplemental Information**

If you have additional information that might help us understand your leadership activities and skills and your professional achievements, please include attachments.

**Recommendations**

Please obtain two letters of recommendation from individuals who are able to speak with certainty about your professional achievements and potential. Please note, applicants may not use TCAA staff as references.

**Application Deadlines & Decision Schedule**

TCAA will offer two fellowships for 2023. The deadline for applications is January 16<sup>th</sup>, 2023.

We thoroughly review each application in the time allowed. Please note you may not be notified regarding our decision until four-to-six weeks following the application deadline.
