# Thursday, 8:30 a.m. Special Guest Speaker, State Rep. Alex Dominguez



Alex Dominguez was first elected in 2018 as the Texas State Representative for District 37. He represents Brownsville, Los Fresnos, Port Isabel, Rio Hondo, Arroyo City, Laguna Vista, and South Padre Island. He serves on the House Natural Resources Committee which considers all water related legislation.

Rep. Dominguez was previously elected to serve on the Cameron County Commissioners Court beginning June 2014. He worked on numerous budgets, hiring decisions, and hurricane preparedness. He worked tirelessly with county personnel to create the first all-inclusive playground to the county parks system.

He earned his BA in Political Science from Rice University in 1993. There he was an avid member of the George R. Brown Forensics Society, Rice Players, and the Justice Court.

He began his career as an educator in the Garland Independent School District where he taught for three years. He taught numerous subjects including ESL, Reading, English, and Texas History.

After teaching, Rep. Dominguez earned his Juris Doctorate from the Sandra Day O'Connor College of Law at Arizona State University. He won numerous awards including the Mueller Award for the most outstanding oral advocate.

He began his legal career as a prosecutor in the Cameron County District Attorney's Office. He quickly rose to become a felony prosecutor. After his time at the CCDA's Office, he opened the Law Offices of Alejandro Dominguez.

Rep. Dominguez was a board member of CASA of Cameron and Willacy Counties for six years. Additionally, he has been a board member and president of the Los Diez Education Foundation for over 20 years helping to raise scholarship funds for first generation college students.

Rep. Alex is married to his wife, Jill. They have one son and two wonderful rescue dogs.

A lifelong Texan, Rep. Keith Bell resides in Forney, Texas. Before being elected to represent House District 4 in November 2018, Rep. Bell served as a trustee on the Forney ISD School Board for 20 years, elected as president fourteen times. Keith Bell has been in the electrical field since 1976. He founded Intex Electrical Contractors, Inc. in November, 1983 and serves as CEO/President.

Keith holds a Master Electrician's License in Texas and served the Texas Department of Licensing and Regulation as past chairman of the Texas Electrical Safety and Licensing Advisory Board. He is also active in numerous trade organizations, including the Independent Electrical Contractors Association (IEC), where he was elected to a two-year term as President of the Dallas Chapter of the IEC, and later served as the Texas IEC Chapter President. Before taking office, Representative Bell acted as IEC of Texas' Governmental Affairs Chairman for almost two decades. Bell also serves on the Board of Directors at Baylor Scott & White Hospital-Sunnyvale.
