Applicants for Associate Membership must designate one category as their primary listing area. Additional categories may be designated if included with your level of Associate Membership. Companies providing services that do not fall into one of the above categories should first send a letter of inquiry and interest to USFN.

ELIGIBILITY

Associate Membership in USFN is intended for businesses that provide services that complement those of the regular members of USFN and that are in conjunction with the mission of USFN.

Law firms and trustee companies are not eligible for Associate Membership. Individuals or entities that provide foreclosure, bankruptcy and/or eviction processing services or serve as a trustee are not eligible for Associate Membership. This is defined as the direct processing of foreclosures, bankruptcies and/or evictions by either the company or a subsidiary of the company. Applicants must certify that they are in compliance with the foregoing, and agree that, if they are not in compliance in the future, their Associate Membership shall be subject to immediate termination.

Companies that are owned by or that own trustee companies or law firms (unless the trustee company or law firm is a member of USFN) are not eligible for Associate Membership.
