QUALIFYING CREDITS (208.4)

CLE Program must:

- A. be designed for lawyer audience;
- B. cover a recognized legal subject;
- C. be delivered as Moderated Programming, or Non-Moderated Programming with Interactivity as a Key Component; The Sponsor must have a system which allows certification of attendance to be controlled by the Sponsor and which permits the Sponsor to verify the date and time of attendance;
- D. provide thorough, high-quality instructional written materials which appropriately cover the subject matter must be distributed to all attendees in paper or electronic format during or prior to the program;
- E. be presented by a faculty member or members qualified by academic or practical experience to teach the topics whether they are lawyers or have other subject matter experience.

ACCREDITATION (208.5)

Regulations accrediting CLE programs are to be established by V.I. Bar. All courses offered by the V.I. Bar, the V.I. Judiciary and the V.I. federal courts are approved; any sponsor may apply for accreditation;

the V.I. Bar may recognize an organization as an "approved sponsor" on its own; Reciprocity recognized for jurisdictions that recognize V.I. Bar accredited programs.

OTHER MEANS OF OBTAINING CLE CREDITS (208.6)

Teaching; publishing an article, chapter, book, revision, or update; Serving on a board or committee of the V.I. Judiciary, the V.I. District Court, the V.I. Bar Association, or the V.I. Bar Admission.

CLE Ethics and V.I. Law Programming credits are automatically awarded to members of the V.I. Board of Professional Responsibility, the Board on Unauthorized Practice of law, Committee of Bar Examiners,³ and the Commission of Judicial Conduct.
