All items for your type of car wash facility must be checked in order to qualify for this program.

X	Self-Serve Wash Facility
	All pressure nozzles are calibrated to flow no greater than 3 gallons per minute.
	Spot-free rinse is turned off if reject water is not used.
	Weep management systems are in place.
	Nozzles are replaced periodically.
	All driveways and impervious areas are swept instead of washed.
	All water leaks are repaired as they occur.
	Main water shut off valve and back flow preventers are in good working condition.

X	Conveyor Vehicle Wash Facility
	Pump head pressures have been refined to reduce consumption.
	Check valves are used wherever possible.
	Conveyor speed has been increased.
	Arches are correctly timed to start and end as car passes under them.
	All driveways and impervious areas are swept instead of washed.
	All water leaks are repaired as they occur.
	Main water shut off valve and back flow preventers are in good working condition.

X	Roll-over/In-bay Automatic Vehicle Wash Facility
	The number of soap passes has been reduced, if more than one pass.
	Spot-free rinse is turned off if reject water is not used.
	Speed of cycle have been increased.
	Spray bars have been renozzled and/or calibrated to no more than 30 gpm.
	All driveways and impervious areas are swept instead of washed.
	All water leaks are repaired as they occur.
	Main water shut off valve and back flow preventers are in good working condition.
