Restrictions and Policies

The discount programs are available to any WBA member. Staff members of a WBA member may attend any CLE seminar at the member rate, but are not eligible for the Cheaper by the Dozen program. Staff may use their firm's Better by the Bulk hours.

The discount program does not cover lunch if a lunch is provided during a CLE seminar. You must notify the CLE Director if you will not have lunch or you will be charged.

Hours may be used in one-hour segments, i.e., members may attend one hour of a four-hour seminar and be charged for only the one hour, or the number of hours actually attended.

If an attendee claims 0.5 hours of a seminar, the account will be charged the next higher whole hour.

A registrant may cancel their attendance with no penalty, up to 24 hours (1 day) prior to the seminar. After the 24 hour cancellation deadline, a one-hour charge will be deducted from the discount program.

All hours must be used during the CLE compliance year (July 1 - June 28). If there are any additional special charges or a program will not be eligible for discount members, it will be noted on the CLE registration form. Door registrations are accepted, if space is available.

CBD Policy: The attorney will be charged \$30.00 per CLE credit hour for any additional CLE hours exceeding 12 hours.
