The Friend of Pharmacy Award recognizes an individual or organization outside the profession of pharmacy whose activities promote the advancement of pharmacists' role of improving patient medication outcomes and public health.



Friend of Pharmacy Award - Advocate Lis Houchen

Professionally employed in politics since 1978, Ms. Houchen started lobbying in 1990 and began representing pharmacy in 1994 as the Director of the Washington Retail Association's (WRA) Pharmacy Council. In 1997, she left WRA to become one of four Regional State Managers for the National Association of Chain Drug Stores and was later promoted to Regional Director. During her 23 years with NACDS, Lis covered as many as 20 states and as few as 10. Lis has partnered with WSPA, supporting our legislation, actively engaged in PQAC meetings, pulling in valuable examples from other states, and representing pharmacy on the Washington Student Achievement Council. Lis's deep understanding of pharmacy law and regulation is an asset to our profession.



Friend of Pharmacy Award Robert Lutz, MD, MPH

Bob has been an incredible supporter of pharmacists providing care to patients in community pharmacies. His partnership on CDTAs has increased patient access to care and the ability of pharmacists to help public health. Bob is a Board-Certified Family Medicine physician. He received his medical degree from Temple University in 1988, his Family Practice Residency, and a Sports Medicine Fellowship at Bayfront Medical Center in St. Petersburg, Florida, and his Master of Public Health from the University of Arizona. Upon moving to Spokane, WA in 2004, Bob served on the Spokane Regional Health District's Board of Health for eight years, until being appointed as the Health Officer for Spokane County, WA, from 2017-2020. He currently serves as the Health Officer for Asotin County, WA, board member of the Washington State Board of Health, and medical advisor for the COVID-19 response for the Department of Health.

She is a licensed pharmacist, a Clinical Professor and served as the Vice-Dean for the Washington State University College of Pharmacy and Pharmaceutical Sciences. She is a past president of the WSPA, is a past trustee for the American Pharmacists Association, and serves as a board member and the vice-president for the Community Pharmacy Foundation. Linda has been a passionate supporter of WSPA, looking to promote and partner with the association to advance community pharmacy practice where pharmacists assess patients and are responsible for outcomes, communicating with other health care providers to assure continuity of care.



Health System Pharmacist of the Year

Ms. Kristy Clare is a Pharmacy System Administrator for Central Washington Hospital. Her primary focus is overseeing and ensuring compliance within Confluence Health's 340B program. Kristy has successfully advanced Confluence Health's 340b program to include in-house pharmacy, satellite locations throughout North Central Washington, and a contract mail order pharmacy. She has a knack for communicating to and educating individuals unfamiliar with the 340b program, including Confluence Health's C-suite, in an incredibly effective way. Additionally, Kristy has accepted Pharmacy Technician Students that rotate through the 340b department as part of

their externship. This has increased awareness within the community and expanded knowledge of alternate avenues for pharmacy technicians to grow their careers into lesser-known areas. Lastly, Kristy successfully led Confluence Health through its first HRSA audit last April, with ZERO findings. It is also worth noting that Kristy excelled in this position with no prior experience with 340b and no one to mentor her!

Dr. Ahmed Ali is a pharmacy owner and active member within the Somali community in Seattle and works closely with King County – Seattle Public Health, emphasizing immigrant and refugee health. He also serves as one of the founders and the current Executive Director of the Somali Health Board, a grassroots organization with ambitious goals of reducing and eliminating health disparities that disproportionately affect the Somali population throughout King County and Washington State. Ahmed's pharmacy, Othello Station Pharmacy, has been an essential partner in and model

for addressing COVID-19 disparities in their diverse Seattle neighborhood, providing access to the vaccine, and overcoming barriers. His hands-on approach, including creating a video of him getting his COVID-19 vaccine for Somali refugees and educating his community, has been inspiring. Ahmed was born in Somalia and currently lives in Kent with his wife and children. Additionally, Ahmed has served in various advocacy, policy, and systems change positions in many community and government advisory roles. He's a WSU College of Pharmacy graduate, class of 2008.

Angie is working with WSPA, University of Washington, and her WSU peers to create a rural track focusing on behavioral health for multiple healthcare professional students to increase access to healthcare for rural communities. Angie is valued for her participation in numerous professional and community organizations and promoting leadership within the pharmacy profession. She has a strong commitment to finding the strengths in those she mentors

and encourages them to endeavor to their success and recognize areas of opportunity. As a clinical pharmacist and academic scholar in Washington for almost two decades, Angie has participated in numerous efforts where her leadership acuity benefited and promoted the mission, vision, and goals of her involved organizations and projects. Distinguished Young Pharmacist of the Year Award

Annalisa omas, PharmD

Annalisa, a graduate of the University of Washington School of Pharmacy, is a leader who has been instrumental in pioneering innovative pharmacy practices that allow pharmacists to perform at the top of their license. During her Community Practice Residency, she helped develop the nation's first Pharmacy-based PrEP clinic providing comprehensive HIV prevention, a model for pharmacies across the country, and the basis for the California law. Working for Kelley-Ross Pharmacy, Annalisa was one of the first pharmacists in a community pharmacy to bill medical insurance for patient care and has partnered with

WSPA to educate others about how to create this sustainable model. Annalisa oversees the annual distribution of thousands of Narcan doses to community partners with King County Public Health. Her leadership during the pandemic has been exemplary. She led employee health and safety efforts as well as co-led the Kelley-Ross immunization campaign, organizing mass vaccine clinics that helped deliver over 12,000 doses to their community.

Pharmacy Student of the Year

Emma Cousin (University of Washington)

Ms. Emma Cousin has served as a model for being an engaged and active member of the pharmacy profession. As a WSPA Student Board Member, Emma has excelled at demonstrating flexibility while guiding the student chapter through a pandemic. After successfully leading over a hundred students to Olympia for Legislative Day for two years, Emma pivoted and created the opportunity for students to advocate for policy in Washington State through a virtual legislative week. In addition to her service to the WSPA, Emma has served as an educational assistant and co-lecturer for the elective advocacy course for three academic quarters. She has also held leadership

roles in the student chapters of AMCP (Director of Public Relations), SNPhA (Mental Health Initiative Co-Director), and co-led the school's first involvement in the ACT Collaborative's 1st National Day of Service. Emma has maintained an internship at UW Medicine. In addition, she has partnered with WSPA on the Moon+ Stepwise Pharmacy Naloxone Study and conducted a systematic review on sickle cell disease.

Amanda Stringham, BS, CPhT

Amanda Stringham is the instructor of the Wenatchee Valley College Pharmacy Technician Program. She attended Western Washington University in 1997 and graduated with a Bachelor of Science in Chemistry. After working as a chemist for several years, Amanda found inpatient pharmacy better fit her interests. She became a Nationally Certified Pharmacy Technician in 2002. In 2007, Amanda assisted in converting the chemotherapy infusion center into a pharmacy-led program where she continued to work as a chemotherapy certified technician until 2019. After a year working with the advisory board for the pharmacy technician program at Wenatchee Valley College, she applied for and was selected as the instructor and coordinator. Under the supervision of the director, Amanda has developed a robust, comprehensive four-quarter technician training program that prepares students to pass the Pharmacy Technician Certification Exam. Amanda works to inspire individuals to become pharmacy technicians in an area of critical need in Central Washington State.

Karen Van Wagenen

Karen is a veteran pharmacy tech of 25 years and Lead Buyer at Swedish Medical Center Hospital. She was extraordinary in her support of Remdesivir distribution, including organizing and supporting the Western Washington distribution of the federal/state supply. Karen was instrumental in coordinating the logistics of Remdesivir distribution and worked with DOH to receive, store and distribute to all hospitals in Western Washington (and some in Eastern Washington) for several months. She developed a process that was efficient, accurate, and thorough.

The Pharmacist of the Year Award honors pharmacists who possess qualities of excellence in routine practice and association activities, is an exemplary role model, and who has contributed to the service and skill of WSPA during the past year.

Nick Bruck, PharmD

Dr. Bruck has served as the District Manager for Walgreens Boots Alliance and on the WSU College of Pharmacy and Pharmaceutical Sciences Dean's Advisory Council, in addition to multiple other committees and councils in Washington State. Over the past 19 years that Nick worked for Walgreens, he has been a huge supporter of public health and an unwavering responder to Public Health Emergencies in the Spokane Region. Nick is always quick to answer a call from the Spokane Regional Health District or WSPA, rallying the staff and resources of Walgreens to respond to mumps, measles, and meningitis outbreaks. Ms. Beverly Schaefer is distinguished for her innovative approach to practice as the owner of Sandpoint Pharmacy and the lead innovator of the WSPA Clinical Community Pharmacist Certificates and CDTAs.



Dr. Bill Fassett is distinguished for his service to WSPA as the originator and presenter at the WSPA Annual New Drug New Laws session. He is also appreciated for authoring Washington Pharmacy Law and his support of the Washington State Pharmacy Foundation.




