RE: RECOMMENDATIONS FOR SECOND VICE PRESIDENT & BOARD OF DIRECTORS

In anticipation of our 2018 annual meeting in Cody, Wyoming it is time again to be looking at nominations for second vice president and three new board members for your trade association, Wyoming Bankers Association. **The Annual Meeting will be held on Tuesday, June 12, 2018 at 12:30 p.m. at the Holiday Inn.** Please review the following information.

The bylaws of our Association provide that a nominating committee consisting of five immediate past presidents who are still actively engaged in banking as an officer or director, shall nominate the slate of officers and three directors for the forthcoming year 2018-2019. The nominating committee for this year consists of Chairman, Gary Crum, Gregg Jones, Scott Estep, Leonard Nack, and Jeff Wallace.

In compliance with the bylaws, the second vice president for the up-coming year must be an officer or director of a WBA member financial institution in the **GROUP II - MEDIUM** WBA member category.

The three director nominees will serve three-year terms and shall be divided into three groups based on total Deposits. The three groups would be as follows:

Group I Largest - Shall consist of the eight (8) largest member banks and /or bank holding companies operating in Wyoming.

Group II Medium - Shall consist of the one-half of the remaining banks, not included in group I, which have the highest total deposits per bank.

Group III Small - Shall consist of the one-half of the remaining banks, not included in group I or II.

At this time the small group would be defined as under \$139,999 million, \$140,000 to 490,000 million is the medium group. *See attached for bank breakdown.*
