## **Wyoming Telecommunications Association 2019 Procedure for Financial Need Scholarship**

1. Applicants must complete and sign the application form.
2. Applicants must complete all sections of the application. While attachments are acceptable, do not simply reference the attachments when completing the application. (i.e., do not simply say “see attached”)
3. Applicants must provide a copy of current transcript with cumulative grade point average and SAT/ACT scores if available, or equivalent college or trade school transcript.
4. Applicant must submit a general resume including education, employment and community work.
5. Applicants must provide a personal evaluation of the applicant by an educator, community leader, or employer.
6. Applicants must provide Customer Verification Form from the serving telecommunications company.
7. Applicants must provide a one (1) page essay explaining the applicant’s reason for obtaining an advanced education.
8. Applicants must provide a statement of need – at least one (1) paragraph in length.
