**New Local Criminal Rule 576**

As you are already aware, the York County Local Rules of Criminal Procedure have been updated and will be in effect this Friday, July 1<sup>st</sup>.

I wanted to draw your attention to a particular rule, York R. Crim. P. 576, which will change where you deliver the court's(judge) copy of filings. You will be delivering BOTH the original filing, AND the court's copy to the Clerk of Courts. The Clerk's staff will place the court's copy in the drop box for Court Administration.

Please advise your support staff, administrative assistants, runners etc., of the following:

- Filings should be prepared so that any proposed order you choose to submit with your motion accompanies the court's copy, not the original
- Copies for the court will no longer be accepted in Court Administration. They must accompany the original when filed with the Clerk.

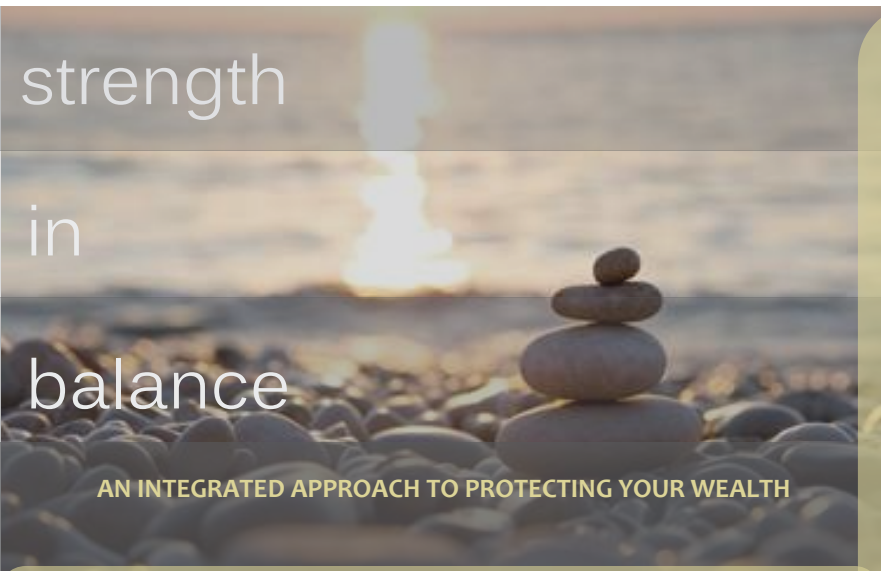


